Special Issue: Challenges and their Appropriate Policy Responses of the Asia-Pacific Economies in the Next Decade

SYNOPSIS AND SUBJECT COVERAGE

For the past few decades, the Asian Pacific economies have achieved impressive rates of economic growth. However, these economies now face significant challenges such as climate change, widespread anti-globalism sentiments that express themselves in the US- China and other trade conflicts, demographic change, financial innovation and cyber security. These challenges impact on the future standards of living of these economies, which call for appropriate policies from governments in the region.
